### SUPERVISOR COMMENTS

Officers responded to a report of a vehicle collision that turned out to be a robbery in-progress that was taking place in the middle of the roadway. Three males from the bay area had come to Turlock to meet a female who was selling French bullies. One of the

males gave the victim \$2,000 for two dogs and while the victim was counting the money one of the males grabbed it from her hands and tried to drive away with the dogs. The victim attempted to get the dogs back by entering the back seat of the suspect's vehicle, at which time the suspect driver accelerated with the victim half way in the vehicle. The driver lost control and crashed into a light pole, knocking the victim onto the ground and causing injury to her leg. At this point a second vehicle pulled up and the suspects from the first vehicle got into it and they drove away. As officers arrived in the area they saw a vehicle leaving at a high rate of speed, at which time a pursuit was initiated. The pursuit went onto HWY 99 and officers lost it as they entered into Modesto. A short time later CHP located the vehicle and another pursuit was initiated. Information was also given that there was a 5-year-old child in the vehicle, and that the suspects had thrown out one of the dogs during the pursuit, which was then ran over by another vehicle. The pursuit went all the way to the Altamont where the driver leg-bailed. Then, one of the passengers got in the driver seat and drove off, starting another pursuit. Eventually two of the suspects were arrested and transported back to meet TPD officers in Modesto. As of the time of this log, the third suspect that leg-bailed was still outstanding. A perimeter was set up and a search was being done. All suspects will be wanted for several felonies, including robbery, aggravated assault, animal cruelty, pursuit, and child endangerment, and hit & run.
