Today's swingshift started out with an alleged aggravated assault, right after briefing. TPD received a call from a subject who said he was assaulted by a male, during a struggle the male was punctured with a knife, and that the male was now trying to strangle his wife. Multiple officers responded to the location and secured the scene. It was discovered that the suspect started by arguing with his stepson. He then moved to his wife and the stepson tried to intervene. When the stepson saw that the suspect was strangling his mother, a tussle ensued and both males fell to the ground. It was during that time that the suspect was stabbed with a knife the stepson was holding. The injury was superficial and not life threatening. In the end, the suspect was charged with aggravated domestic violence, aggravated assault, and elder abuse. While being treated for the superficial stab wound, the suspect had low blood pressure and he was required to be admitted to the hospital overnight. Once he is medically cleared he will be taken to the county jail. I had to assign a patrol officer to the medical clearance, which brought me below minimums for a short time. Officers will stand by at the hospital until he is medically cleared. Right after that call, officers responded to a possible Hit&Run collision in which a white pickup truck collided with several parked cars and witnesses stated he was trying to flee. Officers arrived quickly and located the

truck in question. It was found he was not trying to flee. The driver was not impaired, and was speaking with his wife via Bluetooth, when he lost control of his truck. He drove onto the sidewalk and eventually collided with a tree, sign, and 2 parked cars. There were no injuries reported.

It was a busy night for graveyard officers last night. We responded to a residence three times within a short time of each other reagrding a father and adult son who were not getting along. The father was intoxicated and it was later determined through video evidence that each time he called to report something the allegations were made up. He had called 911 on each call, which was not an emergency. Officers arrested the father for misuse of 911 and filing a false police report. He was taken to jail. Several officers also responded to a traffic accident at Golden State and Monte Vista. A female driver had collided into the train track crossing arm pole, causing a lot of property damage. The vehicle was significantly damaged and was stuck on the train tracks. Additionally, a train was in the far distance approcahing. Officers used the push bumper on a patrol vehicle to push the car off the tracks, and Union Pacific was contacted and the train was stopped in time. The driver was determined to be under the influence of alcohol and was arrested. She was taken to the hospiatl for medical clearene and then booked into jail. Union Pacific arrived to begin repairs on the crossing gaurds. Several other arrests were made last night which caused some officers to be out of the city and relying on swing shift officers to hold over to assist.
