#### **SUPERVISOR COMMENTS**

The shift was busy all day and with reports coming in and calls pending. Officers responded to a trespassing call at a vacant home where the owner advised there was no one supposed to be there and the house was being sold. They located several subjects squatting in the house and on the property. The investigation revealed a male and female suspect had forced entry into the home and then claimed the owner hired them to do work. They also stole the owner's truck that was on the property and had been driving it around. They were arrested and booked for trespassing, auto theft and felony probation violation. This afternoon, we responded to fight where the victim was knocked unconscious and sustained significant injuries. A suspect was identified and the investigation is on-going.

#### **SUPERVISOR COMMENTS**

Swing shift had another busy day. The officers spent much of their time responding to calls of disturbance calls. Most were able to be handled without requiring reports. Some however, were not. Officers responded to a report of 10 plus subjects in a verbal argument on the north end of town. As officers were responding, a caller stated that the subjects were now in an active fight. When officers arrived, they located one subject who was bleeding from his face and had a swollen eye. This subject was very uncooperative and stated he fell. He refused to tell officers what happened and started walking away. Officers wrote a report due to the injuries seen on the subject, and advised him to call TPD if he decided to cooperate. No suspects were located. Later in the day, officers made a traffic enforcement stop on a bicyclist. The rider decided to give the officers his brother's name and date of birth. He was afraid that he had a warrant. In the end he did not, and he was arrested for giving an actual person's name as his false name.
