SUPERVISOR COMMENTS

Dayshift handled steady calls for service throughout the shift. Officers responded for a report of an assault between two people at a residence. It was determined they were in a live-in dating relationship. The responsible kicked the victim's phone out of his hand. He was also on parole. He was booked into jail for domestic battery and a parole hold. An officer received information that a wanted person was staying at a local motel. Officers contacted him at the described room. He had a felony narcotic warrant for his arrest and was on searchable probation. He was taken to jail for the warrant. Officers responded to a business on Lander Avenue for a report of a male opening and closing a knife and making racial remarks. Upon arrival, the male was not compliant with the officer's orders but then decided to comply and was detained. He was under the influence of an alcoholic beverage and was arrested and taken to jail for being too intoxicated to care for himself. SUPERVISOR COMMENTS

Officers responded to call regarding a female passed out behind the wheel while in a parking lot. The inside of the vehicle had a strong odor of marijuana and the female showed signs of being under the influence. She was ultimately arrested for DUI and provided a blood sample at the hospital. An officer was flagged down by an intoxicated male who wanted a ride home. The male had been causing a disturbance with customers at a nearby establishment. He also had a restraining order that prohibited him from going to the place he wanted a ride to. Due to his intoxication and inability to make sound decisions, he was arrested and booked for sobering. An officer also contacted a male who had a warrant. While trying to make the arrest the male began to resist and pull away from the officer. He was booked for his warrant and resisting arrest.
