SUPERVISOR COMMENTS

Officers were dispatched to a storage unit for the report of abandoned property in one of the units from the last renter. Officers recovered 14 firearms and TONS of ammunition from the unit. This made 2 officers unavailable for some time while they checked and booked all the firearms for safekeeping. An officer was working overtime at the Jr High School for the Halloween dance. He was notified of an adult male who was walking on campus with a stick, threatening school staff members and refusing to leave the school grounds. The officer was able to detain the male after a short struggle and after searching him, found a concealed fixed blade knife in his pocket. The male was arrested and booked into jail. Street Crimes Unit tried to pull a vehicle over and the driver decided to flee. after a short pursuit, the driver pulled into a driveway of a residence, and a high-risk stop was done. Several patrol officers responded to assist and the male driver was taken into custody. He was on PRCS for robbery out-of-county, and he was booked for felony pursuit.
