SUPERVISOR COMMENTS

The shift started out busy with calls pending. Officers responded to a trespass call where a male went to his ex-girlfriend's home and let himself inside without permission. While there he got into an argument with the victim and began to break things in her room. The male left before police arrived, but an officer spotted his vehicle driving away and stopped him. The investigation revealed a battery had occurred resulting in the victim having injuries. The male was arrested and booked after being served with an emergency protective order. Another DV call was investigated. A male had met with his ex-girlfriend, who is the mother of his children. During their encounter the male grabbed the victim by the neck with both hands and restricted the female's breathing for approximately 15 seconds. The female reported that he only stopped strangling her because a car was driving by. He was gone before police arrived and an I&B for his arrest was completed.
